

Recipe Corner Shredded eye of round Beef

Sliced (not chopped) sweet onion in crockpot and lots of garlic bits. Chunks of eye of round beef browned in pan and then into crockpot. Chopped sweet peppers. No liquid necessary as onion and peppers will produce that resulting in a great gravy. Salt and pepper to taste. When the beef pulls apart easily using couple of forks, stir all together. Meanwhile, potatoes in salt water (I use Idaho baking potatoes) then 3-4 TBS butter, garlic bits, sour cream and ½ & ½ ...when ready for hand mixer. For added kick, I add an egg and whip with the milk and add as you mix. The beef over mashed potatoes is the goal. You can freeze individual servings as shown. Thaw overnight in refrigerator and then into microwave using the reheat setting.

C-SPAN is a private, non-profit public service created by the cable television industry.

Rep. Matt Gaetz, R-Fla., introduced an amendment to the House rules to allow C-SPAN cameras on the chamber floor during normal proceedings.

The amendment would require the speaker of the House to allow C-SPAN to broadcast the floor proceedings of the House, such as during the very entertaining House speaker vote.
