Few weeks back for this recipe...and then the rendered fat from bacon that is baked not fried. Used the rendered fat in the bread recipe!



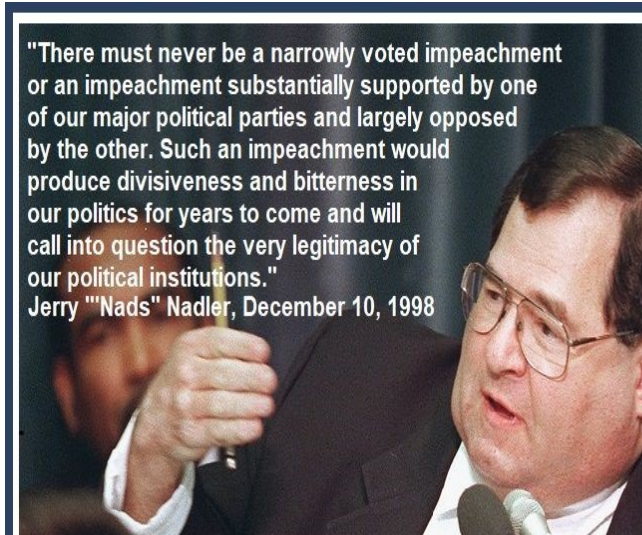

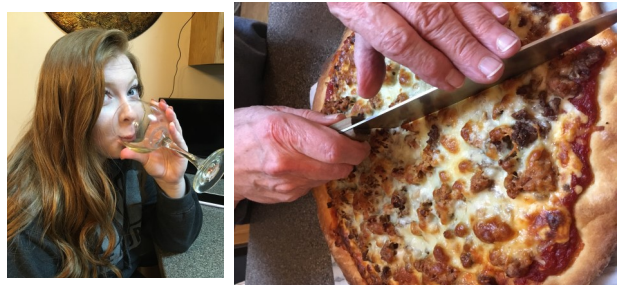

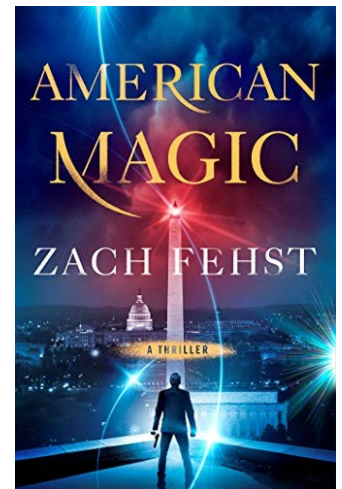


While those idiots in DC were doing their thing, I was doing mine...pedicure with my granddaughter Gracie and her mom Brenda followed by homemade pizza.

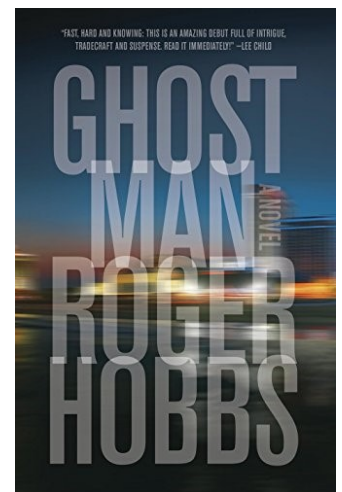
