The U.S. Attorney General has discovered more than 260,000 dead people and several thousand non-citizens during its brief review of voter rolls across the country...thus far.

The Attorney General is uniquely charged by Congress with the enforcement of the National Voter Registration Act (NVRA) and the Help America Vote Act (HAVA), which were designed by Congress to ensure that states have proper and effective voter registration and voter list maintenance programs. The Attorney General also has the Civil Rights Act of 1960 (CRA) at her disposal to demand the production, inspection, and analysis of the statewide voter registration lists.

The Justice Department's has filed federal lawsuits nationwide against a total of 18 states. The Civil Rights Division is also suing one locality — Fulton County, Georgia — for records related to the 2020 election. The states being sued are California, Colorado, Delaware, Hawaii, Maine, Maryland, Massachusetts, Michigan, Minnesota, Nevada, New Hampshire, New Mexico, New York, Oregon, Pennsylvania, Rhode Island, Vermont, and Washington.

The Justice Department has requested detailed voter information including names, dates of birth, residential addresses, driver's license numbers, and partial Social Security numbers. As of December 2025, the department has asked at least 26 states for voter registration rolls, and nearly all have either provided only publicly available data or refused to comply fully. Of course, it's the Democrats who are resisting this review. I think we've had enough strongly worded letters from Republicans. Remember when the Tea Party scared hell out of the Republicans? 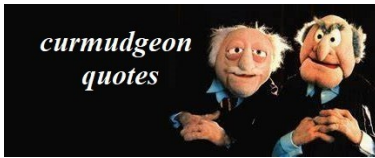
You're smiling and nodding your head. For Democrats, it's not the money from the taxes, it's the power to control the taxpayer. Election fraud always favors the Democrats.
