This time, for higher gas prices but not until after the election. The Biden administration is expected to ease seasonal restrictions on ethanol gasoline blends but has delayed the change until after the 2024 election to avoid a price spike. This will allow the sale of gasoline with 15% ethanol year-round, known as E15 gasoline. Top oil refiners, have warned against the change, saying that it would complicate fuel supply logistics and increase the risk of area shortages, possibly raising prices. The ethanol industry has lobbied for the changes, saying that the environmental concerns are exaggerated. Gas prices spiked nationally to over \$5 per gallon in June 2022 Prices receded to nearly \$3.10 per gallon in December 2022 before climbing up to just under \$3.90 per gallon in August 2023. The national average for a gallon of gas was \$3.276 as of February 20. Biden Admin has eased Electric Vehicle Goals for Union Support. Election year more important than for what we need?

Russian President Putin has further destroyed the Trump-Russia collusion narrative, stating a preference for Joe Biden over Donald Trump.
