
Meanwhile, Trump is twitter fighting with Kelly Ann Conway's husband...



## Here's my latest windmill:

After a few years of excellent service from Frontier at in Pinetop, AZ, I made the decision to try their service at my current location. The internet connection was expected to be at least 5mps of the promised 18mps to enable streaming using a ROKU connection. The service continued to deteriorate and the best I could usually find was 3mps and dropped connections. I contacted Frontier to cancel the service as of October 20, 2018 and was informed to make the final billing on a prorated cost and mark the check as final billing.

I continued to receive billing statements. Phone calls to Frontier indicated that the billing service would eventually catch up with the cancel notice...but never did. I have now received a credit collection notice for their service beyond the final billing date....here we go!

The president of Frontier, the MN commissioner at the Dept of Commerce and the president of the credit collection company are now receiving documentation of the paid bill...and an invoice for my time calculated at my client billing rates. I sent the invoice to the local Frontier store because that involves small claims court because it would be classified as a local business. The invoice includes storage charges for the modems left behind by the Frontier techs when they tried fixing the problem. I even included an internet connection log showing the discrepancy between Frontier and Spectrum service (3mps vs 200mps). Yes...I'm enjoying this!
