

Recipe Corner Carne Bean and Rice Ingredients:

Cup of pinto beans
Cup of rice
Two cups chicken broth
Pound of hamburger
Or cubed beef
Chopped sweet onion
Three strips of bacon
Cup of Quesadilla cheese
Cup of salsa
Can (drained) diced tomatoes (or two cups of salsa)

Pirections:

Directions: Soak beans overnight and then boil until done. Cook rice in chicken broth. When both are drained and cool, mix with the tomatoes, cheese and salsa. Cut bacon in bits...then cook adding beef and the chopped onion. Let cool and add to mixture. I use Pyrex dishes and bake at 350 until cheese is melted; about 15-20 minutes. When done, spread sour cream on tortilla, spoon mixture over the sour cream, roll up and enjoy. Add a lime to your Dos Equis and you're ready for a gourmet treat. Extra tip: mash and fry some of the pinto beans in the pan after you've cooked the meat. Add it to the mixture as an extra binder beyond the cheese. Cilantro, celery leaves and some Taco seasoning used when cooking the beef provides additional


We can see you Fauci!
