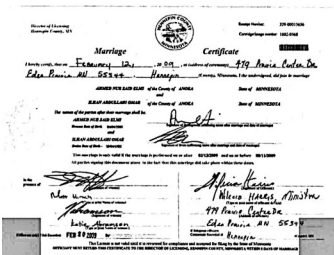




Get the popcorn ready...

Election integrity...meaning preventing the Democrats from cheating...will be the primary issue in the coming midterm election. The mail-in ballot has been their most effective weapon. That will soon come to a screeching halt as the USPS regulations from President Donald Trump's March 31 executive order, which, among other things, directed USPS to develop rules governing mail-in and absentee ballots used in federal elections have overcome the Democrat sponsored judicial interference. More than 30 percent of ballots cast in the 2024 general election were submitted by mail, according to the U.S. Election Assistance Commission.

The U.S. Postal Service (USPS) new rules that will require states that use their agency for mail-in voting in federal elections to first submit lists of voters who receive mailed ballots. The court injunctions blocking such rules were lifted.

To enroll an individual, state election officials will have to submit the voter's name and address through a new online portal, along with unique "Intelligent Mail barcodes" assigned to both the outbound ballot envelope and the return ballot envelope. The rule also requires outbound federal ballot envelopes to display the official "Election Mail" logo, be compatible with postal automation equipment, and carry a unique barcode much like the serial numbers on money that prevents counterfeiting, or in this case, voter fraud.

The regulations stem from President Donald Trump's March 31 executive order, which, among other things, directed USPS to develop rules governing mail-in and absentee ballots used in federal elections. The rule is scheduled to be formally published in the Federal Register today and lists Aug. 21 as its effective date. USPS said that it will now take steps to implement the rule for the Nov. 3 midterm elections since the court injunctions blocking the relevant provisions of Trump's executive order were lifted this week.

Major US oil companies are now scaling back capital spending and US production while reaping the rewards of higher global oil prices resulting from the war in Iran, despite pressure from the White House to lower oil prices and give it back to us.

Here's what experts predict:

Because of the large draw-down in global inventories triggered by continued disruptions in the Strait of Hormuz, we forecast that oil prices will remain elevated until global oil flows return to normal and oil inventories are replenished.

We estimate that global oil inventories fell by an average of 4.2 million b/d in 2Q26 and that they will fall by an additional 3.8 million b/d on average in 3Q26. As a result, we forecast the Brent crude oil spot price will average around \$85/b in 3Q26, \$11/b higher than in last month's STEO.

Once the traffic through the Strait of Hormuz gradually increases and shut-in oil production increasingly restarts, we forecast oil prices will begin to fall, decreasing to an average of \$78/b by 4Q26. We assess that most shut-in oil production will be largely restored in 1Q27 and that global oil inventories will again start building, gradually lowering oil prices to an average of \$69/b in 2027.

\$69/b would translate to about \$2.60 for national average for gas.

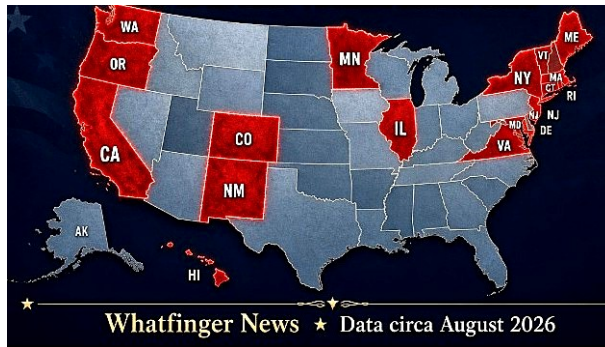

If surplus mail ballots collected from people who aren't voting by mail are somehow voted on behalf of OTHER PEOPLE, it becomes readily detectable that a ballot was repurposed from its originally intended voter to someone else on the voter rolls. The "no-match" condition means that ballot was taken from the originally intended voter or it was given away. Either way that's how fraud can be easily detected.

The barcode matching requirement does not require any personal information that isn't on the outside of an envelope, and it doesn't prevent states from using mail to conduct elections, so the hysterical reactions are confirmation the Democrats know the gig is up.

With mail ballots safe, maybe we should kick up past the 30% using mail ballots and go for at least half.
